Application for Membership

The basic subscription for Full Membership of the Association is £38 per annum.

The RDBKA Membership element of this sum is **£10**; we send **£3** to the Yorkshire Beekeepers Association; and **£23** is allocated to the British Beekeepers Association. Through this affiliation with the BBKA, a member is covered for Third Party Public Liability and Product Insurance.

In addition, a further **£2** is paid to Bee Diseases Insurance (BDI), which covers beekeepers for up to 3 colonies in respect of losses caused by statutorily notifiable honeybee diseases and pests.

Additional colonies can be insured on payment of further premiums (the rates are available upon request from the Treasurer): all colonies within the same apiary must be insured. Insurance is valid Jan-Dec but payments made after 31st March give cover only after 40 days. This is not meant to discourage beginners merely to explain what happens to your subscription.

Friends of the RDBKA who attend Apiary meetings, lectures and/or wish to be included on the News Letter mailing list, are asked to donate £12 per annum. This does not give Insurance Cover or affiliation to other Associations.

Our membership is shared with the Yorkshire Beekeepers’ Association (YBKA), which is our County Association and the British Beekeepers Association (BBKA), the country’s largest charity dedicated to helping Honeybees and the beekeepers that look after them.
